

## **Nedbank Money Quiz Competition**

1. The promoter of the competition is Media24 (“the Promoter”).
2. The competition will commence on 12:00pm on 2 December 2019 and will close midnight on 31 December 2019.

### **3. Who can and cannot enter the competition**

- 3.1 All participants in the promotional competition (“Participants”) must be over the age of 18 and must be a South African citizen or permanent resident with a valid South African ID number.
- 3.2 The following persons however are not allowed to enter into the competition:
